## ELE 3717 Consumer Rights

### Introduction

This course in consumer rights focuses directly on the duties that the business community has towards consumers. Several sets of regulations have been formulated with the aim of protecting consumers as a group with appurtenant dispute resolution bodies. However, it turns out that the business community has little knowledge of these rules and therefore risks getting involved in expensive conflicts that could have been avoided if they had been more knowledgeable about consumer rights. It will be both cost-effective for each enterprise and socio-economically worthwhile to improve the knowledge level on consumer rights. The business community must be aware of the rules on consumer rights in order to fulfil their own duties formulated in various regulations.

### Learning outcome

#### Acquired knowledge

The students shall gain a good understanding of the particular requirements in the legislation when a consumer is party to a contract or the recipient of advertising. They shall be aware of the special considerations that have to be taken into account regarding interpretations of contracts or formulation of standard contracts aimed at consumers. They shall also gain an insight into the rules on breaches of contracts and claims in the consumer sales act, as well as an understanding of the rules in the craftsmans service act. The students shall also learn about the systems for conflict resolution associated with consumer disputes.

#### Acquired skills

The students shall be able to account for the main consumer rights and be able to handle consumer issues in practice. They shall be able to identify topical problems within the law of sales disputes and give legally valid advice to consumers in a dispute situation.

#### Reflection

The students shall have a conscious attitude to the ethical dilemmas of consumer disputes.

### Computer-based tools

### Learning process and workload

The course duration is 45 hours, allocated to cover the various topics in the syllabus. The lecture plan will show what topics will be covered. As part of the teaching programme the students will be divided into smaller discussion groups to work on assignments linked to the various topics. The assignments will be discussed in class after the work in the discussion groups.

The lecture form of teaching requires that the students before each lecture have studied the syllabus and the rules of law for the topic in question. The students are required to bring the code of laws and other study aids to the lectures and become familiar with them while studying the various topics. Parts of the syllabus must be studied through self-tuition.

### Use of hours

Regular lectures are given over 34 hours. In addition there will be 11 hours of discussion group work organized by the lecturer, allocated to the various topics. The assignments will be discussed in class and students are required to take an active part in discussions. Two voluntary hand-in exercises will be given which will be graded by the lecturer and the students will be given individual feedback.

#### Use of hours on the various topics:

Entering into and interpreting contracts where one contracting party is a consumer, 7 hours of lectures and 2 hours of assignments

The legal capacity to act of minors, 2 hours of lectures and 1 hour of assignments

Enabling rules, 2 hours of lectures and 1 hour of assignments

The duties of the business community as regards the consumer sales act and the craftsmen service act, 12 hours of lectures and 3 hours of assignments

Complaint rules and dispute resolution bodies, 2 hours of lectures and 1 hour of assignments

The rules on consumers' right of cancellation, 2 hours of lectures and 1 hour of assignments

The rules on marketing aimed at consumers, 7 hours of lectures and 2 hours of assignments

### Examination

A five-hour individual written exam concludes the course.
