Introduction

The course will give a broad introduction to the topic accident insurance. Mandatory in authorization of claims handlers in travel insurance (personal injuries) and claims handlers in personal injuries.

Learning outcome

Acquired knowledge:

The students shall obtain basic knowledge of accidental insurance and be able to give an account of insurance terms and regulations, calculation of damages, calculation of premiums and claims handling.

Acquired skills:

The students shall have developed the skills to give advices and guidance to customers and to deal with contracts concerning accident insurance. The students shall also be able to use this knowledge in basic claims handling.

Reflection:

During the course, the students should have acquired a conscious attitude to the fact that their professional choices and advices first and foremost are of importance for other people than themselves.
